

# Policies - First page to remain with clients!

### Lessons

All lessons are only available in monthly packages of 4, 6, 8, and 12. Lessons are interchangeable for a 30-minute private to 1 hr group. You must be able to walk, trot and post safely off a lunge line to partake in a group lessons and be available during group times. Lesson horses will not jump over 2'3 in fence height. Package lessons must be paid for by the first the month and used in that time frame. If lessons are missed due to client cancellation, they can only be rolled over to the next month. Please be proactive in scheduling your lessons. All Lessons must be used in the month they are purchased.

### **Boarding**

Board must be paid for by the first of the month. If board is not paid by the  $7^{th}$ , the client's card on file will be charged. A 3% credit card fee will apply.

Farrier and any other services need to be paid for within 3 days. A check writing fee will be applied and billed to the client if payment is not provided within time constraint.

\*\*\*Boarding packages will not include less than 8 lessons per month. That is the minimum requirement for 1/2 leases as well\*\*\*

### **Shows**

A \$100 deposit is required 1 week prior to the shows. This will be credited to your account when invoicing is done. This covers out of pocket fees such as shipping. For out of state shows, the deposit amount is \$200 when show accommodations are made. This will cover out of pocket fees such as hotel, golf cart and other costs/reservations associated prior to showing.

Show bills must be paid for within 3 days following the event. If the invoice is not completed within 3 days, the client's card on file will be charged. A 3% credit card fee will apply.

## **Commissions**

For Atlanta Equestrian's time and expertise in helping you find a horse AS A CLIENT, a 10% sales commission is agreed upon. In the event a horse isn't purchased/ leased you will be responsible for expenses directly related to the search (including time, travel, meals etc.)

For Atlanta Equestrian's time and expertise in selling your horse as a NON CLIENT, a 15% sales commission is agreed upon. This agreement applies to both sales and leases.
